


# 2022 PENLINK TRAINING SUMMIT

Greg kicked off the event with the story of his daughter Kelsey's kidnapping and murder. He highlighted both the law enforcement and community responses to the case and how the experience made a long-term impact on his life. He has since set up the Kelsey Smith Foundation and continued in his fight against wrongdoing by entering the political arena. He served first as a state representative and then as a state senator in Kansas, working to get legislation passed to assist law enforcement in future investigations.

Since graduating from West Point more than 30 years ago, he has led high-performing teams as a military officer, special agent, diplomat, and C-suite executive. **RUNNIN' AFTER THE DEVIL: STEVEN ELLIOTT**

Liz and Meredith were a dynamic duo on stage. Their case study detailed a sextortion investigation that went inter-



national, involving multiple minor female victims. Steven Elliott, the perpetrator, victimized at least thirty female minors for years, taunting them and exposing sexually explicit images and videos of them to their friends, family, and communities via various social media platforms. Elliott utilized TOR (The Onion Router) to mask his identity and was successful for years—until these ladies finally caught his one mistake.

## CLOSING KEYNOTE

**SYNCHRONIZING LAW ENFORCEMENT'S EFFORTS AGAINST DEADLY TRANSNATIONAL CRIMINAL NETWORKS**

**Derek Maltz**, Executive Director, Governmental Relations, PenLink, with special guest **Virginia Krieger**, founder of Parents Against Illicit Narcotics

"If you want to connect the dots, you first must collect the dots." A firm believer in the synchronization of law enforcement efforts, Derek Maltz highlighted the criminal activity plaguing our nation and demonstrated how technology can be used to unify efforts and enable agencies to work more efficiently and quickly to combat transnational crimes. Derek brought to the stage a special guest, Virginia Krieger, who shared her story of her daughter, Tiffany Robertson, a victim of illicit fentanyl poisoning. Her story of frustration over the lack of action by legislators to combat this rising issue left everyone with a better understanding of how interagency collaboration is key to success in battling crime in America and beyond.
